- Are a member of New England division and meet the age and/or classification restrictions (see the division newsletter for birth year restrictions)
- Preregister for ALL applicable qualifying tournaments and are a current member of the USFA and are prepared to show your CURRENT membership card. If you do not have USFA membership, you will be required to purchase (\$60) it at the tournament. **TRIPLE FEES WILL BE CHARGED FOR WALKINS ON DAY OF TOURNAMENT**
- Are a U.S. citizen or Permanent Resident who has not competed for another country within three years

ADDITIONAL IMPORTANT INFORMATION

- Check the neusfa website for specific days and times of qualifying events
- Each **age** category and/or different day is considered a separate tournament (i.e., Y14 and Y12 are **SEPARATE EVENTS**). Please check the box for the event(s) (weapons) you are entering and note the age restrictions for each tournament. **Check the division newsletter for birth year for age restricted events.**
- **DO NOT MAIL ENTRY FORM LATER THAN 7 DAYS BEFORE QUALIFYING EVENT. NEVER MAIL REQUIRING A SIGNATURE! You will be charged double late fees if:** entry is not received by printed deadline; **you will be charged triple late fees if** entry is not received at least three days before tournament and/or you show up on the day of the tournament without no preregistration
- Medical refunds may be given if athlete is withdrawn no later than one week before event.

Please note the following important reminders.

- Preregistration is preferred for ALL qualifying tournaments and membership in the USFA is required at all New England Division events. Be prepared to show your CURRENT membership card. If you do not have USFA membership, you will be required to purchase it at the tournament. **ENTRIES ACCEPTED ON THE DAY OF EVENT WILL BE CHARGED TRIPLE FEES.** There will be no exceptions!
- To participate in team qualifying events you must be eligible to compete at the National Championships; i.e., you must be a U.S. citizen or Permanent Resident who has not competed for another country within three years.
- For division qualifiers clubs may enter **up to** four teams per weapon; **clubs may enter up to three teams at nationals.** Minimum three members to a team; maximum four. USFA team rules apply. Teams may not be mixed.
- Please use a separate entry form for each team. All team events are \$45. **All team members must meet age requirements.** (See newsletter for age restricted birth years) Team members that qualify a team do not need to be the ones who represent the club at national championships but they must be eligible to compete at nationals.
- Refunds will be given if team is withdrawn no later than one week before event.
